1. This is to inform you that there will be a Division Post-Conference of the Alternative Learning System (ALS) Teachers and selected Community ALS Implementers (CAIs) on July 8, 2023 to be held at DepEd Davao del Norte Division Conference Room, Mankilam Tagum City aims to validate the result of the assessment of the presentation portfolio of ALS learners and to address issues and concerns relative to the said activity, and improve the procedures and system.
2. Please refer to Annex 1 for the List of Participants.
3. Per DepEd Order NO. 53, s. 2003 or the Updated Guidelines on Grant of Vacation Service Credits to Teachers indicates that attendance/participation in special DepEd Projects and activities which are short term in duration is considered as one of the identified activities eligible for the grant of Service Credits for teachers and Compensatory Overtime Credits (COC) for non-teaching personnel who have served during Saturdays, Sundays, and including Holidays.
4. Thus, this Office will grant one (1) day service credit to the teachers and COC to the non-teaching personnel, who have rendered services on July 8, 2023, Saturday, covered in the above-mentioned activity. It is emphasized that the COC is subject to the existing CSC and CSC DBM Joint Circular No. 2, s. 2004 or non-monetary remuneration for the overtime services rendered.
3. It is expected by this Office that the prescribed restrictions against COVID-19 shall be strictly complied.
4. Meal and snacks and other incidental expenses during the activity are chargeable from 2023 Program Support Funds of Alternative Learning System (ALS).



5. This activity adheres to the strict compliance with Equal Opportunity Principle (EOP) such as no discrimination based age, sexual orientation, gender identity, status, disability, religion, ethnicity, social status, income, class, affiliation or other similar factors/personal circumstances.
