The Department of Education (DepEd), as articulated in MATATAG: Bansang Makabata, Batang Makabansa agenda, has committed to a learning recovery program to address learning loses during the COVID-19 pandemic. This Division, fully supports DepEd initiative to help the students catch up with learning loses and improve learning outcomes and strengthen teacher competence to teach better.

In order to ensure the effectiveness of this program, all Education Program Supervisors (EPSs) and Public Schools District Supervisors (PSDSs) are hereby instructed to monitor the learning camp of their assigned matrix and district-schools for the whole duration of the camp, and provide technical assistance to teachers needing support.
3. The SGOD personnel shall also monitor the utilization of the downloaded Program Support Funds to the schools and provide Technical Assistance as it deemed necessary.
4. Travel expenses of all monitors shall be charged to Division MOOE, subject to the usual accounting and auditing rules and regulations.
5. Attached in this memorandum is the template for the Division and School Learning Camp Monitoring and Tracking Tool to be accomplished during the visit. A weekly submission of the form and feedbacking shall be done to ensure the strengths and weaknesses of the implementation.
