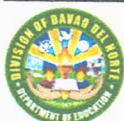

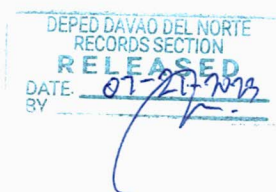

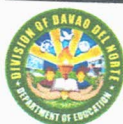
4. Per DepEd Order NO. 53, s. 2003 or the Updated Guidelines on Grant of Vacation Service Credits to Teachers indicates that attendance/participation in special DepEd Projects and activities which are short term in duration is considered as one of the identified activities eligible for the grant of Service Credits for teachers and Compensatory Overtime Credits (COC) for non-teaching personnel who have served during Saturdays, Sundays, and including Holidays.
5. Thus, this Office will grant one (1) day service credit to the teachers who have rendered services on July 31, 2023, Saturday, covered in the above-mentioned activity. It is emphasized that the COC is subject to the existing CSC and CSC DBM Joint Circular No. 2, s. 2004 or non-monetary remuneration for the overtime services rendered.
6. It is expected by this Office that the prescribed restrictions against COVID-19 shall be strictly complied.
7. Meal and snacks and other incidental expenses during the activity are chargeable from the Continuing Fund 2022 under Program Support Funds of Madrasah Education Funds (MEP).
8. This activity adheres to the strict compliance with Equal Opportunity Principle (EOP) such as no discrimination based age, sexual orientation, gender identity, status, disability, religion, ethnicity, social status, income, class, affiliation or other similar factors/personal circumstances.
9. Immediate dissemination of this Memorandum is earnestly desired.
