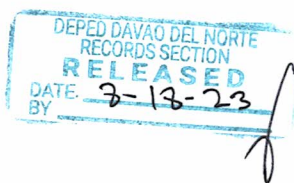
Subject: **BRAULIO E. DUJALI DISTRICT MEETING**
