
Subject: **CONDUCT OF DIVISION ASEAN QUIZ IN PREPARATION OF THE REGIONAL ASEAN QUIZ**

Date: September 28, 2023

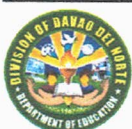
1. Relative to the Regional Memorandum CLMD-2023-584 entitled Regional ASEAN Quiz, this Office announces the conduct of the Division ASEAN Quiz on October 11, 2023 (*Venue to be announced*). The participants of this Division elimination shall be the student winners of the 11 Districts, together with 1 coach per district and school heads. The official list shall be informed after the district elimination.
2. The guidelines and mechanics of the Division elimination:
 - a. Only one (1) entry per district. The contestant shall be a grade 9 learner of SY 2023-2024, between 15-16 years old.
 - b. Each coach of the winning entry shall submit 2 questions for EASY (1 point- Multiple Choice), AVERAGE (2 points- Multiple Choice), and DIFFICULT (3 points- Fill in the blanks). The questions shall be submitted directly to Dr. Grace Santa T. Daclan on or before October 7, 2023. In case of a Tie, a tie Breaker Question shall be given, and whoever answers first wins the specific rank.
3. Expenses relative to the conduct of the activity are chargeable against the PSEF/Division/School/ Local Funds/ MOOE, subject to the usual accounting, and auditing rules, and regulations.
4. Everyone is highly encouraged to continually support and recognize the value of equality and diversity of all personnel while complying with the directives set forth by this office.

Date : September 22, 2023

In support with Proclamation No. 282 dated July 31, 2018 and to increase the interest and awareness regarding ASEAN Community and Sustainable Development Goals (SDGs), this Office informs all Schools Division Offices (SDOs) on the conduct of 2023 Regional ASEAN Quizbee on November 18, 2023 at Davao Occidental Division (specific venue will be announced in a separate Memorandum).

Student-participants (currently in grade 9 ages between 15 to 16 years old) and coaches are advised to be at the venue in the afternoon or evening of November 17, 2023 to have ample time before the competition. Further, the Regional and Assistant Regional Director, chief of the functional divisions, and Schools Division and Assistant Schools Division Superintendents, Education Program Supervisor assigned in Araling Panlipunan, and school head of the contestants are also encourage to witness the competition. It is assure that all will wear the national attire of any member-countries of the ASEAN or UN. In the absence of such attire, any accent or accessories related to the chosen country may be worn during the whole duration of the activity.

Food and accommodation of the participants shall be charged to downloaded funds to the division(ROP-11-23-1340) while travel expenses shall be charged to region/division/school MOOE/local funds and other sources of funds, all subject to the usual government accounting and auditing rules and regulations.

Participants shall be entitled to service credits in accordance with DepEd Order 53, s. 2003 entitled: Updated Guidelines on the Grant of Vacation Service Credits to Teachers. On the other hand, non-teaching personnel shall be provided with Compensatory Time-Off (CTO) as per Civil Service Commission (CSC) and department of Budget and management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
