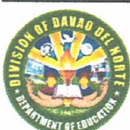

Subject: **SUBMISSION OF LETTER OF INTENT AND TEMPLATE 1-LIST OF LEARNER-BENEFICIARIES FOR THE SY 2023-2024 JOINT DELIVERY VOUCHER PROGRAM (JDVP) IMPLEMENTATION**

Date: October 10, 2023

1. Pursuant to **DepEd Order No. 006 S. 2023 re: Guidelines on the Implementation of the Joint Delivery Voucher Program for Senior High School Technical-Vocational-Livelihood Specialization for School Year 2022- 2023**, this office informs the field on the submission of Letter of Intent and List of Learner-Beneficiaries for SY 2023-2024 JDVP Implementation. Only those qualified SHS-TVL schools shall join this program as stated in the said issuance, that the beneficiaries are the Grade 12 students enrolled in the TVL Track in identified DepEd public SHSs. The said DepEd public SHSs must be assessed and selected by the SDO JDVP Team based on the following criteria;
 - a. Have been offering SHS-TVL for the past four to five years.
 - b. Have been ascertained to have inadequate facilities, equipment, tools and teachers for any TVL specialization for the past two or three years; and
 - c. Are located in areas where there are accessible private SHSs, Non DepEd public SHSs, or private TVIs, which can provide further instructions and training to learners to complete their needed TVL competencies and skills.
2. The Division JDVP-SHS-TVL Team will conduct ocular visit/inspection to all schools who submitted the required documents. The deadline of submission is on or before **October 20, 2023** to give ample time to the Division JDVP-TVL team for the validation process that will start on **October 23, 2023**. Final List of Qualified SHS-TVL schools shall be posted in a separate issuance.

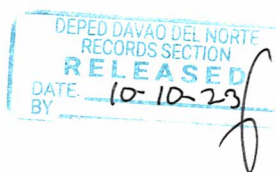
