- Deped Order No. 62, s. 2011 entitled Adopting the National Indigenous Peoples Education Policy Framework and DepEd Order No. 32, s. 2015 entitled Adopting the National IPEd Curriculum Framework provide support and assistance for teaching and learning to happen in a culturally-sensitive and contextualized manner.
