1. The 1987 Philippine Constitution provides for the recognition and promotion of other forms of education other than formal education. Article XIV, Section 2, Paragraph (1) declares that the State shall establish, maintain, and support a complete, adequate, and integrated system of education relevant to the needs of the people and society; and paragraph (4) concisely encourages non-formal, informal, and indigenous learning systems as well as self-learning, independent and out-of-school study programs particularly those that respond to community needs. The Governance Act for Basic Education otherwise known as the Republic Act 9155 stipulates the establishment of the Alternative Learning System (ALS) to provide out-of-school children, youth, and adults population with basic education.
2. In line with the Provincial Executive Order No. 22, Series of 2023 An Order Amending the Provincial Enhanced Comprehensive Local Integration Program (ECLIP) Committee. The 1987 Constitution provides that the State shall promote the welfare of all its constituents and declares that the maintenance of peace and order, the protection of life, liberty and property and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy.
