c. develop among ALS implementers, a deep understanding, familiarization, and appreciation of the Contextualized MELCs-based ALS SHS Curriculum;

 d. enhance the developed lesson plans through unpacking and contextualization of competencies, and feedbacking to demonstration teaching and simulations;

e. provide technical assistance in lesson planning, delivery, contextualization process of learning competencies in ALS; and

f. implement fully the ALS SHS Curriculum in the public secondary schools of the eleven (11) SDOs in the opening of classes S.Y. 2023-2024.

The participants of this activity are stipulated in the attached Annexes 1.A and 1.B. All participants will be accommodated in the hotel venue at 2:00 o clock in the afternoon on November 23, 2023, with dinner provision. Participation of the 126 newly hired ALS Teachers is highly recommended, on this curriculum related training as a pre-requisite skills on the delivery of learning in the school-based/community learning centers.
