- 1. In accordance with the provisions of Republic Act No. 7079, also known as the Campus Journalism Act of 1991, the Department of Education is required to organize activities for student journalists and their advisers. To strengthen selected teachers as coaches/school paper advisers and campus journalists with essentials about journalism, there will be a District Training Workshop on Journalism on November 25-26, 2023, at Sto. Niño Central Elementary School.
- It is advised that all school heads must ensure that NO DISRUPTION of classes shall be observed during the conduct of the activity based on DepEd Order No. 9, series of 2005, Instituting Measures to Increase Engaged Time on Task and Ensuring Compliance Thereat.
- Travel and other incidental expenses incurred by the participants in the conduct of the activity will be charged to any local funds, subject to auditing rules and regulations as prescribed by the Commission on Audit.
- The Equal Opportunity Principle (EOP) shall always be observed where all
  individuals are fully recognized regardless of gender, religion, ethnicity, and political
  affiliations.
- Teacher participants/School Paper Advisers, event facilitators, resource speakers and school heads who will be participating in the said activity will be given service credits and compensatory overtime credits respectively as per DepEd Order No. 53, S. 2003 and CSC and DBM Joint Circular No. 2, S. of 2004.
