- In support of the Department's thrust of promoting the holistic development of its learners through sports and upholding and protecting the freedom of the press even at the campus level, to promote the development and growth of campus journalism, a selection of quality athletes and journalism training will be conducted through the Langilan District Athletic Meet cum Press Conference on December 15-17, 2023, at Gupitan Integrated School, Barangay Gupitan, Kapalong, Davao del Norte.
- 2. This activity is per DepEd Memorandum No. 005, s. 2023 "Conduct of the 2023 Palarong Pambansa" and Sections 6, 8, 9, and 10 of Rule II of the Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 10588, otherwise known as the Palarong Pambansa of 2013. Republic Act No. 7079, s. 1991, "An Act Providing for the Development and Promotion of Campus Journalism and Other Purposes."
- Anent to this, all elementary and secondary schools are encouraged to participate in the sports in which they can compete, and all school paper advisers are to bring their selected participants to the District Schools Press Conference.
- As per compliance with DepEd Order No. 9, s. 2005 "No Disruption of Classes Policy," School Heads shall ensure that the classes are taken care of accordingly.
- 5. The teaching and non-teaching participants who shall render their time and service in the said event shall be given 2-day Service Credit and Compensatory Overtime Credit (COC) as per DepEd Order No. 53, s. 2003 and CSC and DBM Joint Circular No. 2, s. 2004 respectively.
- All expenses relative to this activity shall be charged against school local funds, subject to usual government accounting and auditing rules and regulations.
- Moreover, the Equal Opportunities Principle (EOP) shall always be observed in participating in this activity, where all individuals are fully recognized regardless of gender, religion, ethnicity, and political affiliation.
