

Attached is the Memorandum No. OUF-2022-0525 dated September 22, 2022 issued by USEC Annalyn M. Sevilla, Undersecretary for Finance, Department of Education, DepEd Complex, Meralco Avenue, Pasig City, relative to the reminder on the requests for release of FY 2022 New School Personnel Position (NSPP) Funds classified as For Later Release (FLR).

Since the Implementing Units have frontloaded allotments from regular funds for payment of compensation and other benefits of newly hired teachers in the previous quarters, the PS balance would be insufficient to cover the funding requirements for the last quarter of the Fiscal Year 2022. Hence, all the Schools Division Offices and Secondary Schools Implementing Units are advised to submit the requests for release of allotments under New School Personnel Positions and the corresponding Notice of Cash Allocation to the Regional Office not later than October 31, 2022 for indorsement to DBM Region XI.

Moreover, all other funding requests such as allotments for Optional Terminal Leave Benefits and additional Notice of Cash Allocation covering Sub-Allotment Release Orders and Trust Fund must also be submitted to the Regional Office on or before the abovementioned date.

In view of the November 15, 2022 deadline set by the Department of Budget and Management (DBM) anent agency requests for any funding release requiring the issuance of Special Allotment Release Order (SARO)/additional Notice of Cash Allocations (NCA) as stipulated under Section 3.19, Accountabilities/Timelines, National Budget Circular No. 587, this Office hereby provides the status of the submission of requests for release of NSPP funds classified as For Later Release (FLR) (Annex A).

As of August 31, 2022, a total of Php16.59 Billion NSPP FLR funds remains unreleased. Accordingly, all Regional Offices (ROs) and Schools Division Offices (SDOs) are reminded to fast-track the selection, hiring, and appointment of new teachers. To trigger the immediate release of funds, SDOs and/or Implementing Units must submit the request for release of allotment under NSPP to cover salaries and other compensations of newly hired teachers to their ROs, which will then endorse the same to their counterpart DBM Regional Offices.
