The DepEd Provident Fund (PF) was established by virtue of Administrative Order No. 279 dated May 5, 1992 and implemented through DECS Order No. 97, s. 1992 dated October 1, 1992 which was amended by DECS Order No. 12, s. 2004 dated February 24, 2004, DepEd Order No. 36 dated June 1, 2007 and DepEd Order 37, s. 2018.

The Fund aims to provide DepEd officials and employees with benefits and loans for emergency needs; for their education and that of their children; for their hospitalization and that of their immediate dependents; for minor but immediately needed repair of their houses; and for other similar purposes as determined by the Board of Trustees.

To protect and safeguard the DepEd Provident Fund (PF), this Office hereby issues guidelines on the issuance of Clearance to any DepEd personnel within Region XI with outstanding PF loan balances.

Division Clearance will not be issued to personnel with outstanding PF loan balances upon separation from the service due to resignation, retirement, death. transfer to another agency, and other reasons for severance from employment, including those who will be travelling abroad.

EMPLOYEES WITH OUTSTANDING PROVIDENT LOAN BALANCES

LO PURPOSE

This Order will serve as an internal policy on the issuance of Clearance with outstanding Provident loans in view of the uncollected loan bulances from employee, who were aircady separated from the service and the intention of this Office which is to protect and safeguard the Provident Fund intended for the grant of loans to employees.

2.0 COVERAGE

This Order covers the employees of DepED-Regional Office XI.

3.0 GUIDELINES

- 3.1 . The request for Clearance upon separation from the service due to resignation, retirement, death, transfer to other Agency and other reasons for separation shall not be issued to employees with outstanding toan balances from the Provident Fund.
- In case of travel abroad which also requires the issuance of Clearance prior to travel item I shall also be applied.
- Upon settlement of the outstanding balance, any unpaid interest shall also be 3.3 computed and settled prior to the issuance of the Clearance.
- In case of transfer of employee from DepED-ROXI to Schools Division Offices (SDO) within Davao Region, Clearance may be granted provided the Accounting Unit this Office will issue a Journal Entry Voucher (JEV) to record the transfer of outstanding loan balance to SDO. The loan balance shall also be recorded by the SDOs in their books of accounts.

3.0 EFFECTIVITY
