The Department of Education (DepEd) recognizes the need for all teachers, learners and non-teaching personnel of their free exercise of religion and profession and profession, without discrimination or preference pursuant to Section 5 Article III (Bill of Rights) of the 1987 Philippine Constitution.
- With the observance of Ramadan from March 23, 2023 to April 21, 2023, DepEd
 respects the rights of all Muslim teaching and nonteaching personnel to observe
 fasting during this period without compromising the continuous delivery of basic
 education services to the public.

Participants to the said activity are advised to wear Muslim attire, men shall wear Polo and Tubaw (only if available); and Abaya or any long dress and Hijab for women.
- 4. Participants to the said activity are attached on a separate sheet.
- 5. Travelling and other incidental expenses is chargeable against local funds subject to the usual accounting and auditing rules and regulations.
- 6. All concerned are required to strictly observe the health protocol as prescribed by the Inter-Agency Task Force (IATF) on COVID 19 during this pandemic.
- 7. Everyone is highly encouraged to continually support and recognize the value of equality and diversity of all personnel while complying with the directives set forth by this office.
