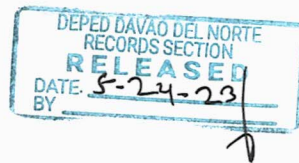

5. Immediate dissemination of this memorandum is desired.

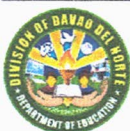

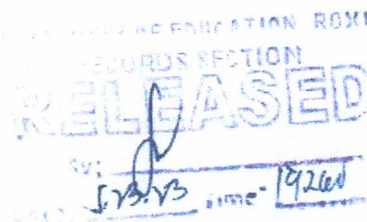
