- 3. Participants to this activity are the DepEd-NEU chapter executives/officials in the central, regional, division and school levels, including but not limited to those occupying positions listed in Enclosure No. I, as well as members of the DepEd-NEU National Board of Trustees (NBOT), National Executive Officers (NEO) and chairpersons and members of the DepEd-NEU steering committees.
- 4. This Office is expecting at least ten (10) participants or more from each SDO (a combination of participants from Division Office Proper, Elementary/ Secondary Schools/District Offices) to actively participate in the said assembly. The elected NEU Region XI Chapter Officers are required to attend, this assembly will serve as a venue to meet and discuss Region XI issues and concerned, including drafting/approving relevant resolutions.
- Representatives from the job groups organized under the Department of Education Association Coordinating Office (DEACO) are enjoined to attend.
- Attendance to these clustered assemblics shall be on Official Business.
- 7. A registration fee of Five Thousand Nine Hundred Fifty Pesos (P5,950.00) for three days shall be charged each participant to cover expenses for supplies and materials, board and lodging, honoraria, travel and incidental expenses of resource persons and facilitators.
- Registration fee and travel expenses of participants shall be charged to their respective local funds, subject to the usual accounting and auditing rules and regulations.
- Members of the NBOT, NEO and the different working committees
 are considered participants and are required to pay registration fee. They are
 authorized to travel two days prior to the start of the activity for the necessary
 preparations.
- 10. Arrival and registration of participants shall be in the morning of Day 1 of each cluster assembly. The first meal to be served shall be lunch on Day 1, while the last meal to be served shall be lunch on the last day of the assembly.
- Pursuant to Section 5 (5) of the Guidelines on the Implementation
 of Community Quarantine in the Philippines, strict social distancing practices shall
 be observed by the participants.
