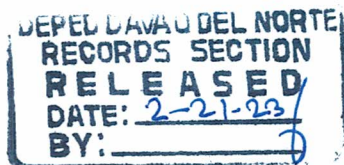
3. All other provisions in the previous issuance not affected by this memorandum shall remain in effect and enforced.
