On the other hand, recipient schools of the Temporary Learning Spaces are requested to ensure availability of a safe and conducive location within the school premises where the DepEd TLS will be constructed.

Further, all expenses incurred shall adhere to accounting and auditing rules and regulations, and close coordination with the Division DRRM Focal Person and/ or Division Engineer, including the Division Budget/ Finance unit are advised for all recipients to ensure efficient implementation of the projects.
