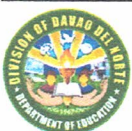

2. The following are the additional recipients with the details of their respective fund allocation, to wit:

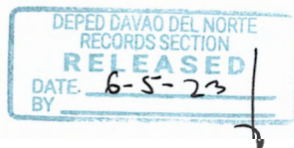

1. Relative to the provision of clean-up and minor repair funds, all recipients are advised that the fund amounting to P20,000.00 shall be utilized for purchase of supplies and equipment, payment of labor services for non-DepEd personnel, and other related expenses for clean-up and minor repair of classrooms affected by series of earthquake in Davao de Oro.
2. To expedite the processing and implementation of the response funds, recipient schools of the clean-up and minor repair fund are requested to submit a Supplemental APP, Work and Financial Plan (WFP), and Program of Work (POW). Once approved, downloading of funds



shall be requested by submitting necessary documents required by the Division Budget/ Finance unit.

3. Recipient of the Temporary Learning Spaces (TLS) is requested to ensure availability of a safe and conducive location within the school premises where the DepEd TLS will be constructed. The Division Office shall facilitate the construction of TLS.
4. Further, all expenses incurred shall adhere to accounting and auditing rules and regulations, and close coordination with the Division DRRM Focal Person and/ or Division Engineer, including the Division Budget/ Finance unit are advised for all recipients to ensure efficient implementation of the projects.
5. It is reiterated that prudent use of the funds must be adhered to and prompt action from the concerned School Heads are requested to ensure immediate utilization and completion of the projects.
6. Proper documentation before, during, and after the implementation must also be complied and submitted to the Division for subsequent submission to the DRRMS.
7. Everyone is enjoined to continually support and recognize the value of equality and diversity as well as ensure STRICT adherence to the health and safety protocols in all undertakings relevant to the activity.
