Subject: Tree Planting Activity for Elementary and Secondary Graduating Students

- 1. This has reference to DepEd Order No. 5, s. 2014 entitled "Implementing Guidelines on the Integration of Gulayan sa Paaralan, Waste Management, and Tree Planting Under the National Greening Program". All schools are enjoined to conduct Tree Planting Activity with the participation of all Grade six (6) and Grade twelve (12) graduating students. Each learner shall plant at least ten (10) native and indigenous trees in the school vicinity or within the identified location in the community.
- 2. In this regard, the Youth for Environment in Schools Organization (YES-O) coordinators shall spearhead the conduct of the activity in coordination with the Grade 6 and 12 teacher-advisers. It is also encouraged to engage internal and external stakeholders for support, especially in the provision of resources.
- 3. Further, as part of the activity, there shall be brief orientation on the importance of planting native and indigenous trees, planting distance, planting methods, tips on caring and growing of trees, and provision of tree seedlings.
- 4. After activity report (one-page with photos in jpeg/png file) shall be submitted online through the link and QR code below on or before July 21, 2023. It is also requested to upload photos of the tree planting activity in the school's social media accounts and use #DepEdDavNorYESO and #DepEdNationalGreeningProgram for advocacy purposes.
