- Relative to the conduct of the National Achievement Test for Grade 10 (NATG10) on June 27, 2023, please be informed on the release of testing materials to the respective Public Schools District Supervisors on June 26, 2023 at 1:00 p.m. in the Division Office. Meanwhile, the respective school heads shall return the said testing materials back to the Division Office on June 27, 2023, starting 4:00 p.m.
- 2. The Technical Working Group members (see attached) shall facilitate and lead the preparation, release, retrieval, and monitoring of the NATG10 materials before, during, and after the conduct of the examination, including weekends.
- 3. Travel, meals and other expenses incurred in the activity shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
- 4. Personnel who render services during weekends shall earn corresponding service credits and compensatory overtime credits (COC) as stipulated in DepEd Order No. 53, s. 2003.
- 5. It is emphasized that everyone shall observe and follow the minimum health protocols in accordance with the Inter-Agency Task Force Against Infectious Disease (IATF) and Department of Health (DOH) rules and guidelines, while the Equal Opportunity Principle (EOP) must always be upheld.
