- Homeroom Parent-Teacher Association	- Within 30 calendar days from the
- Grade-Level Parent-Teacher Association	first day of the class
- School Parent-Teacher Association	- Not later than September 27, 2023
- Federated Parent-Teacher Association	- Within 60 calendar days from the
(Municipal Level)	first day of the class
	- Not later than October 28, 2023
- Federated Parent-Teacher Association	- Within 75 calendar days from the
(Provincial/Division Level)	first day of the class
	- Not later than November 13, 2023
