SUMMARY PROGRAM DESIGN NATIONAL MARKET SCOPING FOR SUPPLEMENTARY LEARNING RESOURCES (SLRs) THROUGH BOOK FAIR

BRIEFER: Procurement of SLRs begins with the identification of titles through market scoping, guided by the Scoping Tools in book fairs, market surveys, NBDB catalog, bookstores, and the like.

Being an institutional buyer of books in the Philippines, DepEd is maximizing its participation in the **1* Philippine Book Festival** which will be conducted in two sessions: one for Luzon cluster of regions and another for Visayas and Mindanao cluster of regions. The three-day activity titled "National Market Scoping for Supplementary Learning Resources (SLRs)" will be conducted alongside the 1st Philippine Book Festival, with the program design of both activities woven to meet all components and objectives. Moreover, a complimentary booth for DepEd, through the Bureau of Learning Resources (BLR), will be set up where original works from various programs will be exhibited.
