MONITORING AND TECHNICAL ASSISTANCE PROVISION TO MULTIGRADE

SCHOOLS OF TALAINGOD DISTRICT

Date: September 11, 2023

- 1. DepEd Order No. 63 s. 2010 stipulates that the Multigrade Program in the Philippine Education (MPPE) is one of the viable mechanisms for increasing access to quality elementary education. It is, therefore, a policy of the department that the program be continued, pursuant to the provisions of the Constitution that the State shall protect and promote the rights of all citizens to quality education.
- 2. Moreover, in DECS Order No. 96, s. 1997, emphasizes the regular monitoring of MG Classes to sustain training gains and to provide teachers with technical as well as instructional support. In consideration of the difficulty in reaching these schools due to distance and poor and/or irregular transportation facilities, principals or supervisors are authorized to collect actual transportation expenses incurred during monitoring and/or supervisory visits.
- 3. With the above given provisions, **Dr. Exelsis Deo A. Deloy**, Education Program Supervisor Focal for Multigrade Education Program, **Dr. Ronnie A. Publico**, PSDS-Talaingod District, and **Lynnelle Joy T. Dayaganon**, School Head, Gatong Elementary School, Talaingod District are hereby directed to conduct monitoring and Technical Assistance Provision to Multigrade Schools of Talaingod Districts on September 22, 2023.
- 4. The said activity is in support to the MATATAG agenda of the Vice President of the Republic of the Philippines and Secretary of the Department of Education (DepEd) Sara Z. Duterte to "take good care of the learners by promoting learner well-being, inclusive education, and a positive learning environment".
- 5. Travelling expenses of the above-mentioned personnel shall be charged against Program Support Fund for Multigrade/ division MOOE/ or any local funds still subject to the usual accounting and auditing rules.
- 6. Everyone is highly encouraged to continually support and recognize the value of equality and diversity of all personnel while complying with the directives set forth by this office.
- 7. Immediate dissemination of this Memorandum is desired.
