Travelling and other allowable expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations.

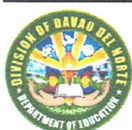


