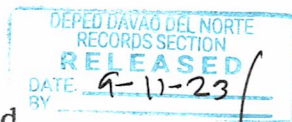

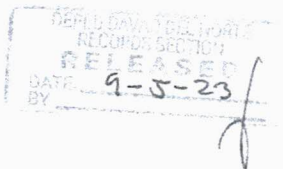

8. Other matters regarding programs implementation.


