Pursuant to Section 34 of the General Provisions of the General Appropriations Act for FY 2022 which provides that all agencies of the government shall formulate a GAD Plan designed to address gender issues within their concerned sectors or mandate and implement the applicable provisions under R.A. 9710 or the Magna Carta of Women (MCW), Convention of the Elimination of All Forms of Discrimination Against Women, the Beijing Platform for Action, the Philippine Plan for Gender-Responsive Development (1995-2025), and Philippine Plan (2017-2022). The GAD Plan shall be integrated in the regular PAP's of the agencies which shall be at least five percent (5%) of their budget.

Based on the Audit Observation Memorandum (AOM) No. 2023-012(2022) entitled Compliance with Gender and Development, the Department of Education as an agency failed to comply with the mandatory requirement of allocating at least 5% of the total GAA for GAD programs, activities and projects.

To be able to address the audit findings and ensure that Region XI is able to properly utilize the GAD budget, there will be a conference of all Division and Regional GAD Focal Persons to prepare the GAD Plan and Budget 2024 at the Schools Division of Panabo City on December 11, 2023.

Foods/snacks shall be chargeable against Division GAD-Funds of the host division, Panabo City while traveling and other related expenses incurred related to this activity shall be chargeable against local MOOE Funds, subject to its availability and the usual accounting and COA rules and regulations. (Refer to enclosure I for the list of participants.)
