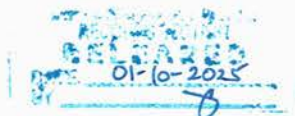
Subject: DISSEMINATION ON THE 2025 PREMIERE EXCELLENCE AWARD




