Subject: **CONDUCT OF MAPPING FOR THE PROPOSED ESTABLISHMENT OF SCHOOLS**

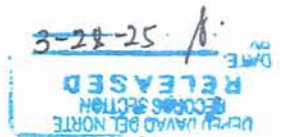
Date: March 25, 2025
