- capacitate the members of the Regional/Division Screening and Accreditation Committee on the revised rules on screening and accreditation of athletes and coaches for the Palarong Pambansa 2025;

Participants are expected to be at the venue on **September 15, 2025** and the first meal to be served is **Breakfast**. The last meal to be served is **Dinner** on **September 18, 2025**.

Expenses such as food and accommodation of all participants, and travel expenses of the members of NSAC, personnel of the Palarong Pambansa Secretariat and other offices shall be charged against the 2025 Physical Fitness and School Sports (PFSS) Funds, while travel expenses of the RSAC/DSAC chairpersons and/or representatives, Regional Sports Officers (RSO) and ICT representatives shall be charged against their respective MOOE/local funds, subject to the usual government accounting and auditing rules and regulations.
