### Objectives:

This award aims to recognize and celebrate schools that have successfully achieved zero non-readers through the implementation of effective literacy interventions, the promotion of a strong reading culture, and the fulfillment of the Department of Education's vision of ensuring that **every child becomes a reader**.

### Specifically, it aims to:

- 1. Recognize schools that have successfully eradicated the number of non-readers through systematic and effective reading interventions.
- 2. Encourage the sustained implementation of evidence-based literacy programs and interventions aligned with the ARAL Program.
- 3. Inspire school leaders, teachers, learners, and stakeholders to work collaboratively in fostering inclusive and functional literacy.
- 4. Motivate other schools to strengthen their reading initiatives by showcasing best practices and successful models.
- 5. Contribute to DepEd's broader mission of providing equitable, quality education where no learner is left behind in reading.

#### Mechanics

### 1. Eligibility

- All public schools within the Division are qualified to participate.
- The School must have officially submitted its updated reading profile to the Division Reading Coordinator

#### 2. Basis of Declaration

A school may declare "Zero Non-Readers" after:

- Completing reading assessments for all enrolled learners in all grades levels.
- Documenting that every learner can reach the **Instructional Level** as defined in the Philippine Informal Reading Inventory (PHIL IRI)

## 3. Submission of Proof

- a. Schools must submit:
  - Reading Assessment Reports (signed by the School Head and Reading Coordinator)
  - Summary of Reading Intervention Programs conducted
  - Certification of Zero Non-Readers signed by the School Head, verified by the School Reading Coordinator, and attested by the Public-School District Supervisor.

### 4. Verification Process

- a. The Division Reading Assessment Team will conduct spot-check validation through random learner reading demonstrations or interviews.
- b. Validation visits may be unannounced to ensure authenticity.



### Composition of the Division Reading Assessment Team:

- 1. Chief Education Program Supervisor, CID Chairperson
- 2. ARAL Program Focal Person Co-Chairperson
- 3. Education Program Supervisor for English Learning Area- Member
- 4. Education Program Supervisor for Filipino Learning Area Member
- 5. Education Program Supervisor for Science Learning Area Member
- 6. Education Program Supervisor for Mathematics Learning Area Member

### 5. Recognition of Winners

- a. The first three schools (based on the date and time of complete, verified submission) will be declared winners.
- b. Winners will be recognized during the Kinaduyuwan Awarding Ceremony or during Division MANCOM and shall be featured on the Division Website and Facebook Page

### Zero Non-Reader Milestone Award

The Zero Non-Reader Milestone Award is conferred upon schools that have successfully ensured every learner achieves functional literacy. This award recognizes the school's commitment to providing inclusive, quality education where no child is left behind in reading proficiency.

#### Rationale:

The Department of Education, through DepEd Order No. 18, s. 2025m, institutionalizes the National Learning Recovery Program (ARAL Program) as a strategic response to address learning losses and ensure that all learners acquire foundational skills in Reading, Mathematics, and Science. Central to this policy is the Department's commitment to eliminating non-readers in basic education through systematic interventions, continuous progress monitoring, and strengthened support mechanisms across governance levels.

Reading is a fundamental skill that serves as the gateway to all forms of learning. A learner who struggles with reading is at a higher risk of academic underperformance, school disengagement, and lifelong socio-economic limitations. The Zero Non-Reader Milestone Award is therefore established to recognize schools that successfully implement effective reading interventions aligned with the ARAL framework, ensuring that no learner is left behind.

This award serves as both recognition and a measure of accountability. It acknowledges schools that have:

- 1. Rigorously implemented progress checks and formative assessments to identify learners at risk of non-reading (as emphasized in Items 43–45 of DO 18, s. 2025).
- 2. Provided sustained and evidence-based reading interventions until learners achieve grade-level competencies.
- 3. Mobilize teachers, parents, community stakeholders, and local government support in fostering a strong culture of reading.
- 4. Demonstrated measurable improvement in learners' literacy outcomes, contributing to DepEd's vision of inclusive, equitable, and quality education.

Ultimately, the Zero Non-Reader Milestone Award reflects DepEd's broader goal of ensuring functional literacy for every Filipino child, in alignment with the Department's Agenda and the ARAL Program's core objective of learning recovery and acceleration.
