Subject: **CONDUCT OF THE 2025 PSYCHOLOGICAL FIRST AID FACILITATORS' INTENSIVE WORKSHOP AND PFA TRAINING**

Date: September 15, 2025

1. This Office, through its Disaster Risk Reduction and Management (DRRM) Unit in partnership with the School Health Services Unit, shall conduct a 3-day live-in **Psychological First Aid Facilitators' Intensive Workshop and PFA Training** from its original schedule on September 3-5, 2025 to **September 29 – October 1, 2025** at **Cris Inn, Tagum City**.
2. The PFA training aims to address the concerns of learners and personnel who are exposed to disasters and distress. These events may affect their performance in school and overall wellbeing. Hence, there is a need for a pool of available responders who can provide PFA to affected individuals.
3. Attached is the list of schools, personnel, and Technical Working Group members requested to attend the said training. School Heads and Non-Teaching Personnel are the preferred participants to ensure that classes will not be disrupted. For smooth logistical preparations regarding accommodation and groupings, and should the school opt to send a Non-Teaching Personnel in lieu of the School Head, **participants are requested to confirm attendance by registering on or before September 19, 2025** through <https://tinyurl.com/PFATraining2025> or scan the QR below:

4. Further, participants are advised to wear decent and comfortable clothing as the training will include arts- and play-based activities as well as simulation exercises.
