4. Meals, snacks, and accommodation of all participants, including supplies and materials shall be charged against DRRM Program Support Funds. However, travelling and other




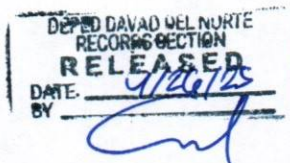
