Subject: **VETTING AND VALIDATION OF SCHOOLS FOR CONSTRUCTION OF LEARNING CONTINUITY SPACES**

Date: January 14, 2026

1. In line with the upcoming implementation of the Learning Continuity Spaces (LCS) for this year, this Office announces the conduct of the Vetting and Validation of Schools tomorrow, January 15, 2026.
2. The primary objective of this activity is to ensure that the proposed schools meet the technical and administrative requirements set by the Disaster Risk Reduction and Management Service (DRRMS) Central Office. The validation will focus on the following:
 - a. Reviewing submitted lists and IMRS based on current field conditions;
 - b. Verifying the justified need for LCS in the identified schools;
 - c. Confirming available and buildable space for LCS installation; and
 - d. Ascertaining school commitment to source funds for site preparation costs exceeding the ₱50,000.00 support fund from DRRMS.
3. To facilitate a comprehensive and timely validation, two (2) teams are hereby organized:

5. The final vetted and validated list, duly endorsed by this Office, must be prepared immediately after the validation for submission to the DRRMS Central Office no later than Friday, January 16, 2026 (End of Business) to ensure the timely downloading of funds.
6. Travel and other incidental expenses relative to this activity shall be charged against local funds/MOOE/DRRM Downloaded Funds subject to the usual accounting and auditing rules and regulations.
7. In adherence to all policies, everyone is encouraged to continuously support and value Equal Opportunity (EOP) within the Department.
